BOCAGE APPLICATION PROCESS

Step-by-Step of Bocage Application Process & 10-day Posting Period

STEP 1. TURN IN APPLICATION

Email your completed application to Membership Director renee@bocagerc.org this begins your 10-day posting period. You are also more than welcome to stop by and drop your application off in our Main office in a sealed envelope with attention to Renee Dugas.

STEP 2. SPONSORING MEMBERS

Please contact your TWO Sponsoring Members and ask them to email Renee Dugas their letters of recommendation regarding your potential membership. Sponsoring members must be active Bocage members and from two separate Bocage Memberships.

STEP 3. 10-DAY POSTING PERIOD

During this time, please provide Membership Director with Headshot or Family Photo for directory and a Voided Check for ACH auto-draft dues payments. Also, check in with your Sponsoring Members to ensure they have emailed their letters of recommendation.



STEP 4. HEADING TO THE BOARD

Once your 10-day posting period has ended, your completed application will be sent to the Bocage Board of Directors for approval.

STEP 5: WELCOME TO BOCAGE!

It typically takes 1-2 business days to get the completed vote by the Board and to get your Active Membership set up in the Club system to get you rolling as a member. Once you are in, I will send you an email with member number, website login, etc...

TYPES OF MEMBERSHIPS

STOCK HOLDING MEMBERSHIPS

FAMILY MEMBERSHIP

This membership is available to legally married couples. The stockholder must be eighteen (18) years of age or more and have been approved for and accepted membership in the Club.

SINGLE MEMBERSHIP

This membership is available to a single person, male or female, no less than eighteen years of age, unmarried or legally divorced, widowed, with no children, or with children over 25 years of age, has been approved for, and has accepted membership in the Club.

SINGLE with DEPENDENTS MEMBERSHIP

This membership is available for single persons, male or female, no less than eighteen (18) years of age, unmarried, legally divorced, or widowed with unmarried dependent children less than 18 years of age or who have dependent children between the ages of 18 and 25 residing at home or are in college, have been approved for and have accepted membership in the Club.

SPECIALTY MEMBERSHIPS

LEGACY MEMBERSHIP

This membership is available to any family member of a stock-holding member in good standing upon the stock-holding member moving into the retired membership category of the club, resigning from the club, or passing away. The stock-holding member shall be allowed to transfer their share of stock to the new legacy member without charge by executing a stock transfer form. The legacy member shall be required to pay all other initiation, capital improvement fees and dues, and must meet all other qualification requirements and approvals as provided for in these by-laws.

PREVIEW MEMBERSHIP

A Preview membership is available for new members who would like to try the club for a 4 month maximum in the months of **January, February, March, April, May, September, October, November, and December.** **Preview Memberships must follow the same Board application processes.** After Board approval, Preview Membership pay only dues for those 4 months that the applicant would like to try the club. At the end of the preview period, Preview Members will have preference to continue as full members by paying the applicable fees.

ONE-TIME FEES DUE UPON BOARD APPROVAL

- Capital Improvement fee
- Stockholding memberships are also required to purchase one (1) share of Bocage Class A stock (\$1,000) within thirty days of the Board's approval. ***Class A stockholders are entitled to all privileges in the Club including the right to vote and hold office.***

Fees must be paid in two separate checks for these amounts since they go into two separate accounts- Capital Improvement & Stock Accounts vs. our Operating Account for dues drafts, etc...

NON-STOCKHOLDING MEMBERSHIPS

JUNIOR MEMBERSHIP

This membership is available when the primary member is no less than eighteen (18) years of age and no older than thirty-four (34) has been approved for and has accepted membership in the Club. A Junior Member is entitled to all privileges in the Club except the right to vote or to hold office. A junior member is not required to purchase a share of stock, however upon either the primary member or spouse reaching the age of thirty-five (35), or after being a Junior Member for five (5) years whichever occurs first, the privileges of being a Junior Member shall terminate and said Junior Member shall be required to purchase a share of stock within a time frame and at the price set by the Board of Directors. If a Junior Member makes application to become a full Family Member, and if there is no waiting list, said Junior Member applicant shall have preference and priority over other applicants for membership. If the Family Membership is at maximum, then the Junior Membership will be extended until a full Family Membership becomes available.

JUNIOR FAMILY MEMBERSHIP

JUNIOR SINGLE MEMBERSHIP

NON-RESIDENT MEMBERSHIP

This membership is available for any club membership defined above, that reside beyond a forty (40) mile radius of the Club. A Nonresident Member is entitled to all the privileges in the Club except the right to vote or to hold office. Non Resident Members are not required to purchase a share of stock.

NON-STOCKHOLDING SPECIALTY MEMBERSHIPS

JUNIOR LEGACY MEMBERSHIP

Dependents of active family members, that have been active members for a minimum of five years, may apply for a Junior Membership for a \$500 Capital Improvement fee between the age of 25 & 34, if the family membership remains active. All other requirements of the Junior Membership apply.

RETIRED MEMBERSHIP

This membership is available for a stockholder member who has maintained their Class A or B membership without disruption for twenty (20) years, or who has been a Class A or B member for a total of twenty-five (25) years with a disruption, and in each case has reached the age of sixty-five (65) years, or who has been a Class A or B member for a total of twenty (20) years and has reached the age of seventy (70) years, and has elected to be granted retired membership upon application to the Board and surrender of their stock. The age requirement shall apply to the named stockholder or the spouse. A Retired Member is entitled to all privileges of the Club except the right to vote and to hold office.

HONORARY MEMBERSHIP

This membership is available for a person, male or female, who, by virtue of outstanding and unusual merit, has been offered, and has accepted an honorary membership in the Club. An Honorary Member is entitled to all the privileges in the Club except the right to vote or to hold office. Honorary members are dues exempt.

ONE-TIME FEE DUE UPON BOARD APPROVAL

- Onetime, non-refundable Capital Improvement Fee
Capital Improvement fee must be paid by CHECK
